Do You Need a License to Operate a Boom Lift?

Yes. OSHA requires certification (operator license) before use.

OSHA Aerial Lift Certification Requirements

- ✓ Operators must complete formal training before using an aerial lift.
- ✓ Training includes safety lessons, evaluations, and documentation.
- ✓ A certified trainer must perform the evaluation.
- ✓ A Train-the-Trainer course allows companies to certify an in-house evaluator.

OSHA Aerial Lift Training Expiration

- ✓ Aerial and boom lift certifications expire every 3 years.
- ✓ Employees must complete renewal training to stay certified.
- ✓ For renewal, workers may skip the class if they are confident in their skills.
- ✓ A certified trainer must still complete the evaluation.
