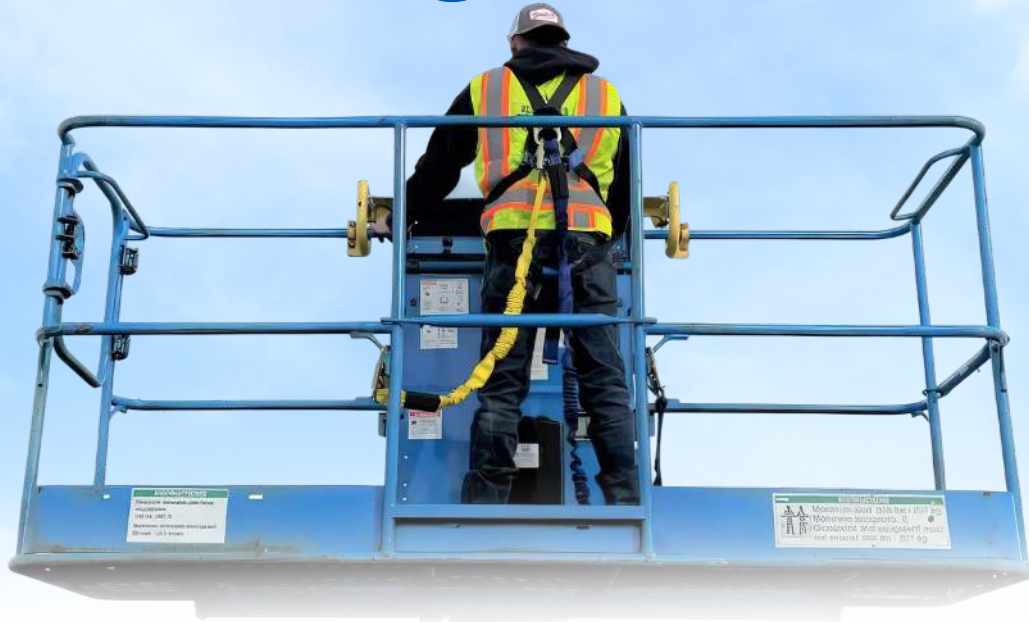

- ✓ OSHA requires training before workers are exposed to fall hazards.
- ✓ A certified trainer must complete required evaluations.
- ✓ Training is required at any height where fall protection is needed.
- ✓ Different jobs require different training:
  - ✓ Fall protection alone may not cover aerial lifts or forklifts
- ✓ Some equipment requires both training and a skills evaluation.

## Fall Protection Certification Process

- ✓ Employees complete online fall protection training modules.
- ✓ Some certifications require a hands-on evaluation.

## Training Covers:

- ✓ Using personal protective equipment (PPE)
- ✓ Spotting fall hazards
- ✓ Safe work practices at height

## Employers can:

- ✓ Hire a certified trainer, or
- ✓ Train an in-house evaluator using a Train-the-Trainer kit.
